





We provided pro bono support and further assistance for executive board creation for the Ministry of Defence of Latvia and State Defence Corporation underlining our commitment to enhancing national security.







We took part in the Baltic Capital Markets Conference 2024, the 2nd Baltic Business and Public Policy Summit in Riga.













